2. Set up after 9:00 a.m. Saturday, July 8, 2017. (New location this year – BBQ area will be set up in beer garden area – corner of Nebraska & Thorington St. – 1 block west of previous year location)
3. Contestants meeting at 1:00 p.m.
4. All contestants will be barbecuing pork loin & ribs.
5. The Algona Founders' Day Hormel BBQ Committee will provide 2 whole pork loins to each contestant along with ribs for those barbecuing ribs. Pickup instructions will be provided at a later date.
6. Contestants may use wood, charcoal, or gas
7. Electricity available on a limited basis - please indicate if it is needed – Yes _____ No _____
8. The turn in time to the judges will be as follows:
Pork Loin 4:00 p.m.
Ribs 4:30 p.m.
9. Garnish is optional. If used, it is limited to chopped, sliced, shredded or whole leaves of fresh green lettuce, curly parsley, flat leaf parsley and/or cilantro. Kale, endive, red tipped lettuce, lettuce cores and other vegetation are prohibited. Improper garnish shall receive a score of one (1) on Appearance.
10. Founders' Day Hormel BBQ Showdown Committee will sell tickets to the public to sample the contestants barbecue to benefit the Founders' Day celebration. Public serving will take place from 4:35 p.m. – 6:00 p.m. Contestants are required to furnish a small table, cutting board and knife.
11. Grand Prize winner is not eligible to win any category prize money.
12. Picnic tables provided for public seating. There will be no tent covering parking lot so please plan accordingly.
13. At 4:00 p.m. all people not directly involved with the teams will be asked to leave.
14. No pets allowed.
15. No public admittance prior to 4:35 p.m.
